Campuses

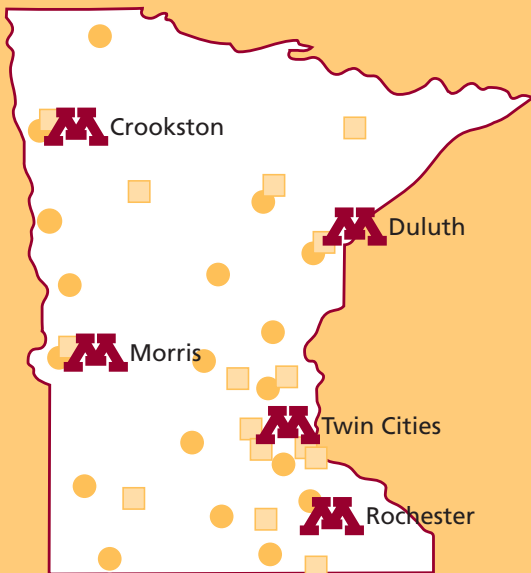
The University of Minnesota, Twin Cities (UMTC), is one of the largest and most prestigious public research universities in the nation.
